I now work for the University's Marine Institute, where I help to champion and deliver on the institute's strategic priorities, supporting academics and research centres across the marine portfolio.

My aim while serving on the Board is to not only support DWT's overall strategy, but also to advance its marine ambitions, employing my scientific knowledge, and operational and management skills.
